- (1) Non-resident students enrolled for 6 hours or less pay the resident rate. If enrolled for 7 hours or more, non-resident students pay the indicated non-resident tuition for ALL credit hours taken.

- (3) Grad, Grad-ASM, Law, Pharm D, Dissertation, and Med students pay a \$25 GPSPA fee per semester.
- (4) Graduate & Non-degree grad rates for students with baccalaureate degree or higher.
- (5) All full-time Physical Therapy D students are charged additional flat tuition fee of \$1,654.00.
- (6) Add \$40 per credit hour for graduate level Architecture, Planning and Landscape Architecture courses.
- (7) Add \$50 per credit hour for graduate level Anderson School of Management (ASM) courses.
- (8) All students enrolled in HSC programs will be charged a \$75 Library Fee.

SENIOR CITIZENS

You qualify for a reduced tuition rate of \$5.00/credit hour if you are:
 * Age 65 or older as of 21st day from the start of the semester.
 * A New Mexico resident as defined by the NM Department of Higher Ed.
 * Registering for no more than six (6) credit hours.
 * Registering on or after August 24, 2009 for the Fall semester.

CORRESPONDENCE COURSES

Students enrolling in Correspondence Courses will be charged at the same rates listed above. However, tuition for these courses is calculated separately and added to any Main or Branch Campus tuition.

Courses beginning on dates other than those listed above, as listed in the *Schedule of Classes* available on LoboWeb, are fully refundable if dropped before 20% of the course has been completed, except for Correspondence courses (see paragraph below). Do not include partial days when calculating 20% of completion. For example, 20% of an eight-day course equals 1.6 days. Refund is calculated only if dropped on or before the first day. Courses five days or less in duration must be dropped on or before the first day of the course to receive a full refund.

Correspondence Courses are fully refundable if dropped before 9% of the course has been completed. Do not include partial days when calculating 9% of completion.

Tuition and fees for courses dropped after the above deadlines will not be refunded.

Students may not drop a course by simply not attending. They are responsible for officially dropping or withdrawing from the University by the published deadlines (see above) to insure proper credit of tuition and fees. A student's readmission, registration, library or parking privileges, release of official records, and other requests may be restricted or denied unless satisfactory financial arrangements have been made for all past due charges.
